Conversion and Printing

Material has a print receptive topcoating in order to give good wettability and ink adhesion with suitable inks, may be printed using letterpress, screen, flexo, offset and gravure processes. Inks suitable for non absorbign surfaces should be used. Protection of the printed surface with a suitable varnish or overlamine is recommended for optimal scratch resistance. Metallised papers are sensitive to humidity and should not be exposed to extreme heat or cold as this may affect the printing performance and surface appearance.
